East Mountain Womenade had a busy 2018. The organization assisted families with emergency financial needs by giving out over \$19,000 in requests. Significant effort has gone toward building strong relationships with school counselors and social workers who refer families to East Mountain Womenade. School personnel, including administrators, continue to report what a difference we are making for families in our community and for students to be successful at school.

Donations from individuals in the community sustain East Mountain Womenade and enough funds continue to be available to fulfill all requests that meet the assistance criteria. Board members cover all organizational expenses so that 100% of all donations go directly to families.
