Dear East Mountain Womenade Supporter,

We are proud to present you with our 2021 Annual Financial Report. Since its inception, East Mountain Womenade has provided \$199,619 of emergency financial assistance to families who have experienced crises such as job loss, domestic violence, death of family members, and various other situations. In 2021, your donations provided 18 families with \$12,430 of assistance. Aid included purchasing gift cards for food and gas, purchasing a solar power system to make a house livable, and filling propane tanks for families.

We are truly grateful for all the financial support we receive from our donors during our potluck fundraising season, and through workplace giving, United Way and Amazon Smile. We want to thank the Mountain Garden club members for their annual donations during their holiday luncheon.
